

ICS2 EU Data Requirements

Introduction

The European Union (EU) is implementing a new customs security and safety program, supported by a large-scale advance cargo information system: Import Control System 2 (ICS2).

According to the EU Union Customs Code (UCC), for all the cargo and mail transported to or through the EU, additional mandatory information shall be provided. Pre-loading advance cargo and mail information (PLACI) will be used by the EU customs authorities to perform air cargo and mail security risk assessments to detect immediate threats to aviation security. Both TAP Air Cargo has adapted its processes and IT systems in order to ensure readiness and compliance towards the entry of this new regulation.

Requirements

HCC Codes (Harmonized Commodity Code) 6 digits

The 6 digits of the HCC code must be provided on the HAWB level, or on AWB level, for direct shipments.

EU EORI Number

The EORI number of the EU Consignee must be provided on MAWB and HAWB level.

Messaging for new requirements

Harmonized Commodity Code for AWB and HAWB

HAWB (for Consolidation Shipments)

In the FHL message, the HCC must be inserted in the HTS line (harmonized tariff schedule information) – explicitly determined to be used for the transmission of the HCC. A maximum of 9 HCC may be inserted per HTS block.
